





# MEMORANDUM of UNDERSTANDING between

# ALEXANDRIA UNIVERSTY EGYPT And

# UNIVERSITY OF MINISTRY OF CULTURE, YOUTH AND SPORTS SOUTH SUDAN

This Memorandum of Understanding is concluded on 8<sup>th</sup> of April 2021 between: ALEXANDRIA UNIVERSITY, represented by Prof. Abdel Aziz Qanswa as University President. (hereafter referred to as the first Party). MINISTRY OF CULTURE, YOUTH AND SPORTS represented by Prof. Albino Bol as Minister of Culture, Youth and Sports, South Sudan (hereafter referred to as the second Party).

#### Preamble:

Both parties agree to coordinate in areas of mutual interest to promote the cooperation through the participation of university staff betwen Alexandria University (the first Party) and Ministry of Culture, Youth and Sports (the second party).

#### Article 1:

Fields of cooperation between ALEXANDRIA UNIVERSITY and MINISTRY OF CULTURE, YOUTH AND SPORTS include the following:

- 1. Exchange students to pursue their training in the fields of mutual interest in specialized/ institutes/ labs.
- 2. Exchange of academic staff for short periods (one or two weeks) or for long periods (semester).
- 3. Delivering lectures.
- 4. Participation in international conferences held at both universities.

5. Participation in seminars training courses and workshops.

### Article 2:

Alexandria University commitments:

- 1. Nominate Faculty members in order to participate in delivering lectures, teaching, training, courses, and workshops, attending seminars and participating in scientific conferences.
- 2. Participation of the South Sudan students registered in Alexandria University in seminars, training courses and workshops.
- 3. The first party will provide their experience for updating labs and research centers.

#### Article 3:

Ministry of Culture, Youth and Sports commitments:

- 1. Ministry of Culture, Youth and Sports will make sure of the commitment of their own representatives in the studying process.
- 2. Providing suitable housing and facilitating accommodation when first party experts are hosted in South Sudan.
- 3. Providing an appropriate training and teaching environment when the programs are established in South Sudan.

## Article 4: Funding:

Both Parties agree that financial commitments are subject to the availability of appropriate funding and they will seek financial support from a third national or international party.

Article 5: Interpretative appendix:

Both Parties have the right to add executive and interpretative appendix to this agreement when it's necessary to be done. This appendix shall be complementary to this agreement and it's considered valid since being signed by both parties.

## Article 6: Duration:

This MOU shall become effective for three years initially upon signature of both parties and may be renewed by written consent from both parties. Either party may terminate the agreement by giving a written notice to the other party six months before the proposed date of termination. This termination must not affect the implementation of the projects or exchanged students programs established under it prior to such termination.
